Notice of consultation on the proposal to change the age range of Stoneferry Primary School,

Background:

Primary

The government have launched a national subsidy for early years education as part of their biggest expansion of childcare provision. This forms a broader effort to improve access to affordable highquality childcare and education. The government and local authorities recognise that investing in early childhood care is critical for supporting working families, enhancing child development and bolstering the economy.

A clear strategy to increase provision city wide is needed to meet this demand. It is already evident that places in private nurseries are at capacity; by widening the early years offer in our primary schools will allow us to increase the 2-year-old provision available to our families.

Specific Proposal:

The Constellation Trust, Stoneferry Primary School and the Local Authority, proposes to develop a provision for 2-year-old children within the existing footprint of the Stoneferry school building. In order to develop this provision, the Constellation Trust is consulting to change the age range of Stoneferry Primary School, from 3-11 to 2-11 years old.

The purpose of this consultation is to provide information relating to the proposal and to seek the views of parents and the wider community.

Stoneferry Primary School currently offers an early years foundation stage curriculum, for 3 and 4 year olds prior to their entry into the school. The Constellation Trust recognises the Governments national scheme to increase support for parents *(as described above)* as an exciting opportunity to expand its high-quality provision to include 2-year-olds.

The expansion will help extend and improve the early years opportunities, making Stoneferry Primary School increasingly attractive to local families.

The proposed provision will offer an additional twelve places for two-year-old children. These places will be for children eligible for free 15/30hrs early education or to parents/carers who wish to pay themselves for this service. The aim of our early years provision is to help support working parents and prepare children for school readiness.

The provision will be delivered from a newly refurbished early years centre, designed specifically for 2-year-old children, with its own private outdoor play area. This facility has been carefully designed and resourced so that it safely meets the needs of children of this age range.
